Noble Creek Irrigation System Decommissioning Working Group

City of Kamloops Council has directed staff to form a working group including representatives of the Noble Creek Irrigation System customers, the Noble Creek Irrigation Society, City of Kamloops staff, qualified professional consultants, and appropriate staff from the Ministry of Forests. The Working Group will be co-chaired by one representative from the Noble Creek Irrigation customers and one staff representative from the City of Kamloops. The Working Group will collaboratively strive to achieve Council's directives including:

- Decommission the at-risk portions of the Noble Creek Irrigation System at the conclusion of the 2023 irrigation season.
 - This includes developing an apportionment plan for the existing water license.
- Exploring options for temporary water supply for the 2024 irrigation season and reporting to Council on the feasibility, cost, funding options, and potential user rates for temporary pumping.
- Completing the decommissioning program payments.

Where possible, the Working Group will be engaged or involved in the steps required to enact Council's directives, but certain steps or directives may not be conducive to customer/public participation due to privacy requirements (example: discussions with individual property owners regarding decommissioning payments).

Working Group Composition:

Working Group Co-Chairs:

The working group will be co-chaired by Adam Woodward, P.Eng as a representative of the Noble Creek Irrigation System customers and City of Kamloops Utilities Manager, Greg Wightman as a City of Kamloops staff representative. The co-chairs will provide periodic reports on the Working Group's activities to the City of Kamloops CAO or designate.

Given the extent of the work required to complete Council's directives, several sub teams will be established. The teams will report to the Working Group Co-Chairs. The teams include:

Infrastructure Decommissioning Team:

This team will focus on achieving Council's directive to decommission the at-risk portions of the Noble Creek Irrigation System at the conclusion of the 2023 irrigation season. The work involved in this directive is mostly operational and this team is being established to support the operational actions required. Noble Creek Irrigation System customer representatives will participate in water license apportionment discussions to ensure the apportionment plan that will be submitted to the Province is mutually supported.

Temporary Pumping Options Team:

This team will focus on achieving Council's directive to explore temporary pumping options for the 2024 irrigation season and report to Council on the feasibility, cost, and potential user rates for this option. The team's focus will be to determine the technical and regulatory information required to support a procurement process for the supply and operation of a temporary pumping system should Council direct staff to pursue this option once it is presented. This team may require availability on weekends as some of the work may be performed between Friday – Monday.

 - It should be noted that due to the urgent timelines, some work may need to occur in advance of these meetings.
- A timeline for the various actions required to achieve Council's directive will be established by the Working Group and reported to the City of Kamloops CAO or designate by Oct 15, 2023.
- A preferred date for the Council report on the temporary pumping options will be recommended by the Working Group Co-Chairs to the City of Kamloops CAO or designate.
- Communication support will be provided to the Co-Chairs by the City of Kamloops Communications and Community Engagement Division as required.
