A single cremation plot can accommodate two cremains.

A single memorial stone is permitted on each cremation plot measuring up to  $12'' \times 20''$ . Side-by-side cremation plots have the option to share one memorial stone measuring up to  $18'' \times 30''$ .

## Fees and Charges

10.

- (a) The fees for interment, inurnment, use of grave space, and care of graves, use of crypts and niches and the charges for goods offered for sale by the City, and any other cemetery fees shall be those set out in said Schedule "A" attached to and forming part of this bylaw.
- (b) The fees set out in said Schedule "A" shall be paid at the Cemetery offices at the time of purchasing a cemetery licence, interment permit or any goods or services sold by the cemetery. Monthly billings to funeral homes for interments/inurnments performed may be approved by the Civic Operations Director.
- (c) The City will not undertake any services until full payment is received by the City.
- (d) Funeral providers opting to not be billed for their client's at-need cemetery service will send the said purchaser to the Cemetery offices where payment will be completed by cheque, Interac, Mastercard, or Visa before any services are performed.
- (e) Any requests for a reduction in the fees set out in Schedule "A", attached to and forming part of this bylaw, will be considered by the Civic Operations Director or their designate.
