

PUBLIC NOTICE IS HEREBY GIVEN that pursuant to section 86 of the *Community Charter*, the City of Kamloops Council is proposing to seek approval of the electors of the City of Kamloops by an Alternative Approval Process. The purpose of the Alternative Approval Process is to determine whether electors are opposed to the City of Kamloops Council adopting the proposed "Arena Multiplex and Recreation Initiatives Loan Authorization Bylaw No. 57-2, 2024".

The design and construction of the Arena Multiplex and future Build Kamloops recreation initiatives was approved, with funding sources designated as fundraising, grants, existing funds, and Municipal Finance Authority debt funding. The estimated cost of the Arena Multiplex portion of this Bylaw is one hundred and forty million dollars (\$140,000,000) and the cost of future development and design work for related Build Kamloops recreation initiatives is ten million dollars (\$10,000,000).

The loan agreement with the Municipal Finance Authority will be for a term no longer than thirty (30) years. The total amount of debt intended to be borrowed by the Bylaw is one hundred and thirty-five million dollars (\$135,000,000) and would result in a twenty-five dollar (\$25) annual tax increase per household over five (5) years.

WHAT IS THE ARENA MULTIPLEX?

The Arena Multiplex would house up to four rinks for multiple ice sports. It would be built on City-owned land at 2070 Hillside Drive, against the boundary of Kenna Cartwright Park. The proposed facility could include a walking track, fitness facility, child play spaces, food and beverage services, and amenities for park users such as bike repair stations and storage, showers and washrooms. Complementary services such as skate sharpening, equipment rentals, and other recreational services could be included. The Multiplex would also provide multi-use space when the ice is removed, which could be used for hosting events and tradeshow, or dryland sports like lacrosse. Additional arena capacity could also allow the City to respond as a host community during emergency events without disrupting recreation and community events.

WHAT ARE THE FUTURE DEVELOPMENTS UNDER THE BUILD KAMLOOPS INITIATIVE?

Curling and Racquet Sport Complex

The proposed curling facility would incorporate the expanding needs of other sports organizations like pickleball, racquetball, and squash that lack play facilities. This facility could increase the City's hosting capability for national and international events and training camps.

Indoor Field Facility

A multi-use indoor field space would provide year-round training opportunities for a variety of field sports, including soccer, rugby, ultimate frisbee, and football. It could increase the City's opportunities to host international competitions, training camps, and events.

Aquatics Facility

This City is actively evaluating locations that could be home to a new leisure pool facility that could accommodate swim lessons, AquaFit classes, and recreational swim time for residents of all ages, particularly families with children.

INSTRUCTIONS

If you are **NOT opposed** to the adoption of the Arena Multiplex and Recreation Initiatives Loan Authorization Bylaw No. 57-2, **you do not need to do anything**.

If you are **OPPOSED** to the adoption of the Arena Multiplex and Recreation Initiatives Loan Authorization Bylaw No. 57-2, you may sign and submit an Elector Response Form indicating your opposition.

A person may not sign more than one Elector Response Form.

APPLICABLE AREA

The area to which the Alternative Approval Process applies is the entire area within the municipal boundaries of the City of Kamloops. Council may proceed with the adoption of Bylaw No. 57-2, 2024, unless before the deadline of **4:00 pm, on Friday, September 13, 2024**, at least 10% of electors submit a complete and signed Elector Response Form indicating that Council must obtain assent of the electors by a referendum vote before proceeding with the adoption of Bylaw No. 57-2, 2024.

For the purpose of this Alternative Approval Process, Council has determined that there are 87,131 eligible electors in the City of Kamloops. Council may therefore proceed with the adoption of Bylaw No. 57-2, 2024 unless at least 8,713 electors submit a completed copy of an Elector Response Form to the City of Kamloops before the deadline of **4:00 pm on Friday, September 13, 2024**.

RESIDENTS AND NON-RESIDENT PROPERTY ELECTORS

In order to sign an Elector Response Form, a person must either be a resident elector or a non-resident property elector of the City of Kamloops. For the purposes of the AAP, an elector is a person who meets the qualifications referred to in Sections 65 or 66 of the *Local Government Act* if assent of the electors were sought, either as a resident elector or non-resident property elector.

To sign an Elector Response Form as a **resident elector** a person must:

- be a Canadian citizen;
- be at least 18 years of age;
- have lived in British Columbia for at least the last six (6) months before signing the Elector Response Form;
- reside within the municipal boundaries of the City of Kamloops;
- not be disqualified by the *Local Government Act* or any other enactment or otherwise disqualified by law from voting in local elections; and
- be entitled to sign the alternative approval process elector response form and not have previously signed an alternative approval process elector response form for the proposed Bylaw.

To sign an Elector Response Form as a **non-resident property elector** a person must:

- be 18 years of age or older;
- be a Canadian citizen;
- have resided in British Columbia for at least six (6) months;
- be a non-resident property elector who lives in another community and have been the registered owner of real property within the municipal boundaries of the City of Kamloops for at least thirty (30) days;
- be the sole registered owner of the real property, or hold it with joint tenants or tenants in common, all of whom are individuals who do not hold the property in trust for a corporation or another trust;
- be the only individual claiming non-resident elector status with respect to the real property;

- have the written consent of the majority of the other property owners on the title to oppose this Bylaw, if the elector is the registered owner of the real property with other individuals;
- If a corporation owns the property in part or in whole, NO Elector Response Form may be submitted;
- **There is NO Corporate vote;**
- not be disqualified by the *Local Government Act* or any other enactment or otherwise disqualified by law from voting in local elections; and
- be entitled to sign the alternative approval process elector response form and not have previously signed an alternative approval process elector response form for the proposed Bylaw.

ELECTOR RESPONSE FORM

An Elector Response Form must be in the form approved by the Council of the City of Kamloops or an accurate copy of the form such as a photocopy. Elector Response Forms are available on the 1st Floor of City Hall, at 7 Victoria Street West, Kamloops, BC, V2C 1A2, between the hours of 8:00 am and 4:00 pm, on Monday to Friday, excluding statutory holidays. The deadline for submitting an Elector Response Form is 4:00 pm on Friday, September 13, 2024.

An Elector Response Form must be fully completed (no initials in name) and hand-signed.

Completed Elector Response Forms may be submitted by:

- dropping them off in person at City Hall between 8:00 am and 4:00 pm, Monday to Friday, except for statutory holidays;
